Registration & Operational fees are non-refundable. Tuition paid in full by **MAY 10, 2011** will receive a **3%** discount.

Registration Fee

This fee is due when registration forms are completed and accepted at the school office. It is Non-refundable.

Operational Fee

This fee is due on April 1, 2011 and is **non-refundable**. If this fee is not paid on time your child(ren) will be removed from the class roster. If this fee is paid late, a 10% late charge will be added and your child(ren) will be placed back on the class roster should space be available.

Volunteer Hours (Pre-Kindergarten(non-VPK) through Eighth Grade)

Each family is requested to complete 20 hours of voluntary service to Blessed Trinity school community. Hours should be completed between May 23, 2011 and May 20, 2012. It is the responsibility of each family to log hours served on the laptop computer in the school front office. **\$200.00 has been added to your base tuition rate.** For each hour served by May 20, 2012, you will be credited \$10.00. Maximum credit \$200 per school year.

FACTS Management Fee

Tuition is collected by FACTS Management Corp. Your bank account will be assessed a \$38.00 fee when your account is established for the 2011-2012 school year. Your first tuition payment will be withdrawn from your account on June 20th or July 5th, 2011.

Tuition Rate

Active Catholic Parishioner rate is based on regular attendance at Blessed Trinity Catholic Church and an average weekly donation of \$15.00. If you do not maintain the requirements of an active catholic parishioner, you will jeopardize your active status resulting in the raising of your tuition rate to the ‘all other’ rate. Active parishioner status must be established three months prior to the beginning of the school year. If you are moving from out of town, you may receive the Blessed Trinity Active Catholic Parishioner Rate upon joining the parish as long as you provide a letter from the Pastor of your previous parish indicating that you were an active parishioner.

Catholics who attend a parish other than Blessed Trinity may receive Active Catholic Out of Parish tuition rate when they provide a letter from their parish Pastor stating that they have active parish status. Should your parish indicate that you are no longer considered an active member, your tuition rate will increase to the non-catholic rate.

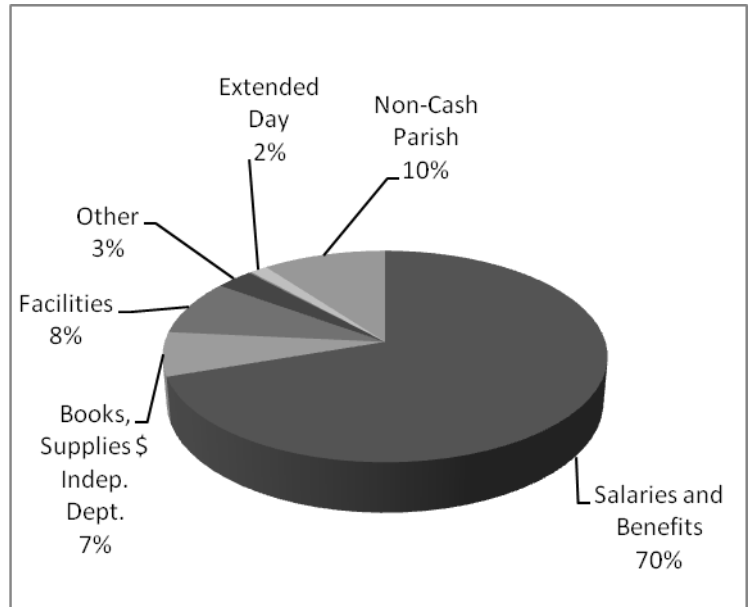
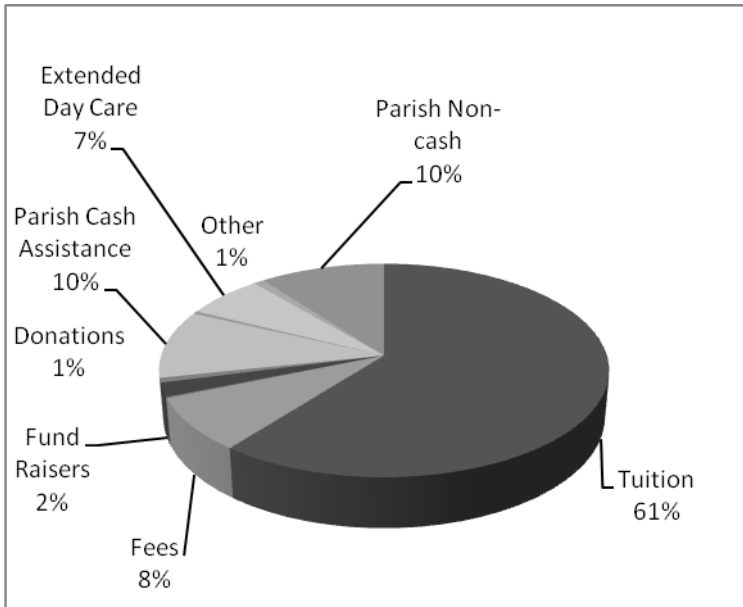
If you do not qualify for Active Parish/Out of Parish Tuition via the above qualifications, you will be charged the All-Other Tuition Rate.
